

Behavioral Intervention Teams (BITs) serve institutions through ongoing assessment of and intervention for individuals within their communities to reduce the risk of violence. To do this work effectively, teams must engage in an ongoing training cycle. This training should include objective risk assessment practices, team processes, and topics relevant to issues of institutional need. Comprehensive team training ensures that BIT members have the skills necessary to fulfill their roles on the team. Additionally, team training promotes trust and supports effective communication within the team, allowing the BIT to operate with greater efficiency and efficacy.

To be most effective, team training should be ongoing, occurring at least monthly throughout the year. Although annual attendance at conferences is helpful, teams should move beyond the once-a-year approach, engaging in growth opportunities throughout the year. Comprehensive team training engages multiple modalities to meet the diverse learning needs of BIT members. Teams report using books, journal articles, and self-led tabletop exercises as methods of training, all of which are low-cost or free (Ulmer & Schiemann, 2022). Most commonly, teams use webinars and NABITA-sponsored events to train their teams (Ulmer & Schiemann, 2022). Although these methods require at least some cost, in-person or virtual trainings pay dividends by providing indepth examinations of concepts and allowing for critical skills practice that will prepare the team for its work.

This Team Training Template provides a framework for engaging in regular, ongoing training built around the 2023 NABITA Industry Standards for Behavioral Intervention Teams. Teams are encouraged to reference this document to help guide team training efforts. This guide outlines NABITA's recommended approach for an annual BIT training cycle and provides resources for team training related to each standard. For simplicity and clarity, some standards have been combined as the training topics and resources overlap.

Standard 20. Team Audit: The team regularly assesses its structure and processes to ensure it is functioning effectively and is in alignment with best practices.

Standard 21: Program Effectiveness: Teams deploy various research methods to assess the team's effectiveness in meeting goals and outcomes.
